2 TENDER DETAILS

2.1 TENDER CONDITIONS

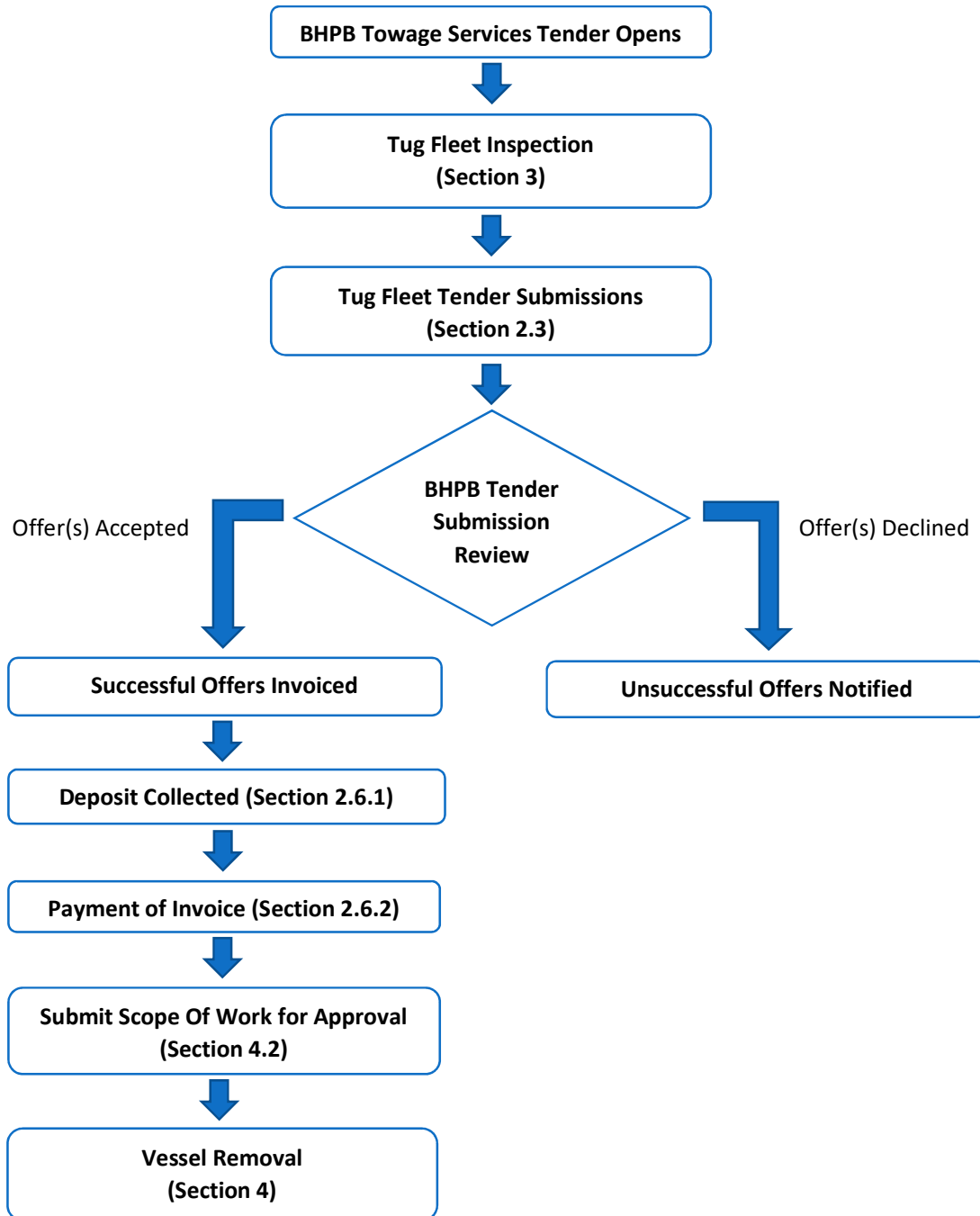

While we have endeavoured to provide correct asset details, any descriptions and photographs of the Lots are deemed to be a guide only. All vessels are used and are sold in "As is Where is" condition.

By submitting an offer you agree that:

- You have been given sufficient opportunity to inspect the Lots to which your tender bid relates and that such inspection was sufficient to satisfy all your inquiries as to the quality and fitness for the purpose to which you intend to use the Lots;
- Your offers for purchase are made based on your inspection and assessment of each Lot;
- If you do not inspect and assess each Lot, your offers for purchase will be deemed to have been made on the basis that you are aware of the quality of the Lots to that extent that such quality would have been evident had you inspected the Lots.

2.3 TENDER DATE SCHEDULE

Tender Submission Deadline: All tender offers must be received no later than 4pm Friday 21st of April 2017 (AWST)

Inspection Period: Asset inspections will be permitted during prescribed inspection periods between Tuesday 28th of March and Friday 31st of March. Please refer to section 3 for full details of inspection dates and attendance registration and requirements.

Tender Decision: A formal tender response by BHPB Towage Services should be made within ten (10) working days of tender close, estimated on Friday 5th of May 2017 (Section 2.5).

Tender Deposit: A minimum deposit of \$50,000 will be required from successful tenderers no later than five (5) days after successful tender notification (Section 2.4).

Full Payment: Full payment will be required no later than 15 working days from successful tender notification

Vessel Removal: All successful tenderers must remove their vessels per vessel removal schedule (Section 4)

2.4 LODGEMENT OF TENDERS

In order to successfully lodge a tender you **must comply** with the following:

- (i) Lodge the tender prior to the closing date of **4pm Friday 21st April, 2017 (AWST)**;
- (ii) Lodge the tender using approved methods outlined in section 2.4.1/2.4.2; and
- (iii) Complete a Capability Statement (Section 4.1)

All offers are to be made in Australian Dollars, exclusive of GST. Please note all offers will be subject to 0.5% Buyers Premium and GST. GST Exemptions for International buyers will need to conform to Australian Taxation Offices rules.

For example an offer of \$2,000,000 AUD will become

\$2,000,000 + \$10,000 (0.5% Buyers Premium) + \$201,000 (10% GST) = \$2,211,000 AUD

GST Exempt Purchases, are required to comply with all Australian TAX legislation including proof of export.

Important: Please ensure you clearly state any special conditions on your tender bids; for example "Only want Lot 2 if successful on Lot 1". Special conditions must be clearly stated in the Comments/Special Conditions parts of the tender submission document or electronic portal.

2.4.2 Written Lodgement

Written tender offers will be accepted. If you wish to lodge a tender in writing, you are required to use the tender submission document provided (see Annexure A) in order for your submission to be considered.

Upon receiving a successful written lodgement, Ross's Auctioneers & Valuers will advise via email or phone call.

2.5 TENDER ACCEPTANCE

BHPB Towage Services Pty Ltd anticipate that the final decision on successful tender will be made within ten (10) working days of the tender close date.

Acceptance of any offer will be communicated in writing (by email, fax or letter) and will be deemed to have been communicated to the successful purchasers immediately (in the case of an email or fax where no notice of transmission error has been received by the sender) or by close of business on the day following mailing (in the case of a letter). Date of such deemed communication will be the "Agreement Date".

Upon the Agreement Date, a binding contract of sale will arise as between The Vendor and the successful purchaser effective on the Agreement Date, the terms and conditions of which are those set out in the Conditions of Tender (Section 2.1).

A Tax invoice will be generated once acceptance has been communicated.

Unsuccessful tenderers will be notified by email.

2.6 TENDER PAYMENTS

3.1 INSPECTION REGISTRATION

3.4 PPE REQUIREMENTS

The inspection site is an active site, thus you must adhere to strict PPE Requirements. You must supply and wear the following PPE equipment at all times:

- (1) Long sleeve High Visibility Shirt;
- (2) Long Trousers;
- (3) Safety Helmet;;
- (4) ANSI approved Eye protection
- (5) Gloves; and
- (6) Safety-toed boots (Over ankle), lace up only.

A Personal Flotation Device will be supplied to registered attendees'. Please note that failure to wear the requisite PPE equipment may result in denied access to the inspection area.

3.5 SITE INDUCTIONS

Site specific inductions will not be required. All attendees will undertake an initial safety brief every morning prior to any inspections. All attendees will be supervised by authorised personnel at all times while they are on site.

3.6 SITE CONDUCT

As attendees will be visiting an active port site, attendees are required to comply with all site conduct requirements. .

Site conduct summary

- PPE must be worn at all times
- You must stay within the designated inspection areas at all times
- No equipment can be operated during inspections unless by authorised BHPB personnel

3.7 OCCUPATIONAL SAFETY AND HEALTH OBLIGATIONS

Legislation of Western Australia imposes mandatory obligations, such as providing and maintaining a safe work environment and preventing exposure to and protection from hazards on persons who use or operate plant in a workplace and on employers whose employees use or operate plant. If the buyer intends to use plant purchased at a workplace then it is the responsibility of the Buyer to inform themselves of these obligations.

Unless otherwise stated the plant to be sold has not been assessed or inspected by a competent person and it may or may not be affected by faults or defects, which make it unsafe for use. It is the responsibility of the Buyer to ensure assessment and inspection by a competent person.

The Legislation requires that owners of plant maintain safety and health information and records. The Auctioneers will pass on to the buyer all information made available to them by the owner, but the auctioneer does not warrant that the information and records are

complete and accurate. It is the responsibility of the Buyer to familiarise themselves with all relevant information and records.

4 VESSEL REMOVAL

It remains at all times the responsibility of the purchaser to remove the vessels purchased from port. The purchaser will make their own arrangements for the removal and collection of the vessels. All vessels will be berthed at the Pilbara Port Authority Port (PPA) prior to removal. Table 4.1 below, outlines the estimated availability of each vessel for removal.

(*) Please note Mount Florance will be relocated to Mackay Queensland during the tender and maybe withdrawn from the tender.

Vessels must be removed from berth within two (2) weeks of final availability. BHP Billiton Towage Services reserves the right to alter or change departure dates due to site operational activities, weather and tidal conditions.

4.1 CAPABILITIES STATEMENT

As a requirement for the tender, all tenderers must supply references and examples of previous equipment removal projects. This ensures that BHPB Towage Services and Ross's Auctioneers and Valuers will have an accurate understanding of the tenderers capabilities of ensuring the safe and timely removal of the vessels.

4.2 SCOPE OF WORK

A condition of sale will be the provision of a scope of work from the Buyer that will provide as a minimum, the following information:

- The successful tenderer will be required to complete a sales agreement. The agreement will utilise the BIMCO Salesform (2012) format;
- All removals will be in accordance with policies and procedures as required by BHPB Towage Services;
- Tenderers will be required to outline, loading activities including timings, proposed routes of travel, proposed use of contractors and conformance to BHPB Towage Services site specific terms and conditions.;
- A detailed risk assessment and relevant JHA's to be completed and distributed for approval by BHPBIO; and
- All removals will be supervised by a BHPB Towage Services Representative
